## **Commodore Report**

Dear Club member,

The Windycrest Board of Governors has proposed to make some changes to our bylaws. You will find a list of the changes and a strike-through document showing the changes in entirety delivered to your email inbox on September 17.

These changes do a few things:

 They formalize several things the club has been doing for a few years, including legitimizing the way we currently manage the relationship with members who have property stored at Windycrest
Move certain fees that had been defined into the bylaws to a rate sheet published by annually by the BOG so they are in line with the way we publish all the other club fees

- 3. Minor updates to all our policies and club rules
- 4. Add a liability policy

How does this affect the club?

For a typical members' relationship and usage of the club- nothing really changes. All the processes for requesting use of club assets, methods and procedures remain the same. If you are a future board member it better guides you on procedures. If you are the club treasurer or secretary it saves you a lot of future paperwork with the IRS and the Secretary of State because we will have to submit less future changes as a result of stabilizing our bylaws. It also eliminates some risk because a few of our procedures were performed differently in the past and never redefined in the bylaws.

We will vote these changes into effect for the 2018 Fiscal year at our next meeting.
